### Report for Haverthwaite Parish Council

I have followed up on Highways issues but a lot of people are on leave so waiting for feedback.

I continue to meet weekly with Headteachers, College Principals, County staff and Public health we began again on August 25th. It is very helpful as issues can be resolved or passed on to other groups for resolution. Last week we discussed provision for post 16 and it was heartening that the colleges felt that they had sufficient capacity, this week we have an input from Inspira (a careers organisation) offering support for parents who may have found themselves without work as a result of the pandemic. The main topic has been vaccinations and communications by the NHS not going through appropriate channels.

We have sorted out the school affected by the landslip on the West Coast.

Temporary buildings have been put up in the grounds of another school, furniture and equipment have been transferred. Cleaning, school meals and school transport have all been arranged. They will start with remote learning and then open properly on 17th September.

The process of Local Government reform has begun we all know we will stay on until elections May 22 when 2 shadow authorities will be set up but we have to continue until March 23. It gives us 18 months to set up two new unitaries and close down 6 district councils and a county council. There is no job protection for staff and everything has to keep running and deliver services.

I have been working hard with local residents, National Highways and the two M.P.s about the A590 which was at a standstill with long tailbacks on many occasions, some because of accidents and some because of the volume of traffic. Tim Farron and Simon Fell have made an appointment with one of the Transport Ministers. Haverthwaite and Staveley PCs are meeting National Highways, CCC, and LDNPA on September 22nd. The A590 has been an issue raised by many people. I reported that Himalayan Balsam was in evidence on Finsthwaite Lane and the local area.
